The Trans Army is an international collective of trans people committed to protecting marginalized communities and dismantling fascism. This manual outlines the strategies and protocols for establishing effective military liaisons with global armed forces to secure logistical, intelligence, and tactical support. Our mission is to forge alliances with militaries worldwide to counter shared threats, exchange vital information, and cultivate mutual protection. The importance of these alliances lies in their capacity to enhance operational effectiveness, secure vital resources, and create a unified front against the resurgence of fascist ideologies.

We recognize that building alliances with state and non-state actors carries both opportunity and risk. Therefore, this manual provides a roadmap for minimizing vulnerabilities, protecting operational security, and ensuring that our partnerships align with our core values of anti-oppression, autonomy, and liberation.

## Objectives

### 1. Forge Strategic Alliances

- Establish trust-based relationships with global military actors.
- Identify and collaborate with sympathetic factions within national armies.
- Develop backchannel communications with military personnel who oppose fascist movements.
- Cultivate relationships with private security firms and independent paramilitary organizations aligned with anti-fascist objectives.
- Explore potential partnerships with ex-military personnel who possess critical expertise.

### 2. Gather Intelligence

- Secure actionable intelligence on fascist groups and their operational plans.
- Develop sources within military, paramilitary, and law enforcement agencies.
- Build an international database of extremist threats and potential allies.
- Utilize deep web and dark web monitoring to detect extremist activity.
- Establish automated threat tracking systems to predict and preempt fascist activities.

### 3. Acquiring Logistical Support

- Obtain resources, including medical supplies, transportation, weapons, and communication equipment.
- Coordinate supply lines and secure access to safe zones.
- Establish fallback positions and safe evacuation routes.
- Develop redundant supply routes across national borders to mitigate disruptions.
- Coordinate humanitarian logistics to support displaced populations.



#### **4. Strengthen Defense Capacities**

- Develop defensive strategies to protect marginalized communities.
- Train community defenders with military-grade tactics.
- Establish mutual aid systems for security, emergency response, and resource distribution.
- Implement decentralized command structures to enhance operational resilience.
- Develop and maintain critical infrastructure to withstand hostile attacks.

### **Code of Conduct**

#### **1. Confidentiality and Security**

- Maintain strict operational security (OPSEC).
- Use encrypted communications and avoid compromising digital footprints.
- Regularly assess and update information security protocols.
- Educate all liaison operatives on secure data handling practices.
- Enforce compartmentalization of sensitive information to mitigate risks.

#### **2. Mutual Respect and Solidarity**

- Prioritize ethical partnerships that align with anti-fascist, anti-colonial, and anti-oppressive values.
- Respect the autonomy and integrity of allied forces.
- Recognize the sovereignty of local communities and uphold their agency in joint operations.

#### **3. Neutrality and Discretion**

- Avoid ideological entanglements and remain focused on shared goals.
- Prevent exploitation of trans communities or allied groups by external forces.
- Ensure strict adherence to impartiality during humanitarian engagements.



## Phases of Engagement

### Phase 1: Reconnaissance and Assessment

- **Identify Potential Allies:** Map out military factions, dissidents, and opposition elements willing to collaborate.
- **Risk Analysis:** Evaluate the political climate and ideological orientation of potential partners.
- **Operational Feasibility:** Assess the capability of allies to provide logistical, tactical, and intelligence support.
- **Evaluate Long-term Commitments:** Assess the durability and sustainability of alliances.
- **Build Contingency Frameworks:** Identify fallback partners and alternative alliance structures.

### Phase 2: Establishing Communication

- **Initial Contact:** Identify trusted intermediaries to make contact.
- **Secure Channels:** Utilize encrypted platforms for initial exchanges.
- **Assess Commitment:** Gauge long-term reliability and alignment with shared objectives.
- **Establish Diplomatic Groundwork:** Develop protocols for formalized diplomatic interaction.
- **Crisis Contingency Planning:** Design mechanisms for communication during high-stakes situations.

### Phase 3: Negotiation and Partnership

- **Define Terms:** Clarify objectives, boundaries, and expected contributions.
- **Formalizing Relationships:** Draft Memorandums of Understanding (MOUs) when necessary.
- **Continuous Evaluation:** Monitor alliances to ensure mutual benefit and alignment.
- **Conduct Periodic Security Audits:** Identify vulnerabilities and ensure compliance with agreed standards.

### Phase 4: Operations and Coordination

- **Joint Exercises:** Conduct simulations and tactical training with allied forces.
- **Information Sharing:** Develop real-time information channels for intelligence sharing.
- **Emergency Response Plans:** Establish protocols for crisis situations, including coordinated interventions.
- **Establish Unified Command Structures:** Develop frameworks to ensure effective joint command in operational contexts.
- **Simulate Cybersecurity Incidents:** Regularly conduct cybersecurity drills to protect digital assets.



## Tactical Intelligence Framework

### Sources of Intelligence

#### 1. Human Intelligence (HUMINT)

- Develop trusted informant networks within military institutions.
- Gain insights through allied personnel embedded in military structures.
- Deploy undercover operatives to gather high-risk intelligence.

#### 2. Signal Intelligence (SIGINT)

- Monitor and intercept fascist communications.
- Utilize surveillance technologies to track enemy movement.
- Establish remote monitoring systems to continuously assess high-risk zones.

#### 3. Open-Source Intelligence (OSINT)

- Analyze publicly available information to map enemy patterns and activity.
- Engage in social media monitoring to identify potential threats.
- Develop AI-powered OSINT platforms to improve the speed and accuracy of threat analysis.

### Analysis and Dissemination

- **Data Verification:** Cross-check information through multiple channels.
- **Threat Prioritization:** Rank and categorize threats based on immediacy and impact.
- **Information Distribution:** Ensure intelligence reaches relevant parties in a timely manner.
- **Implement Predictive Analytics:** Leverage AI and data science to forecast threat trajectories.



## Logistics and Supply Chain Management

### Resource Acquisition

## Additional Case Studies

The partisans received logistical and intelligence support from Allied forces while maintaining a grassroots structure that prioritized local autonomy. Their use of tunnel networks, resource management, and psychological warfare contributed to their ability to sustain prolonged resistance. Their success highlights the importance of blending traditional military support with unconventional tactics.

### Case Study: The Battle of Kobani (2014-2015)

The Battle of Kobani saw Kurdish YPG/YPJ forces successfully repel ISIS from the strategically important city of Kobani in northern Syria. Despite being outgunned, they leveraged detailed knowledge of the local terrain and decentralized defense tactics. With critical air support from U.S.-led coalition forces, they showcased the impact of grassroots resistance combined with international military aid.
