- Anti-Protest Laws: Increasing penalties, banning masks, expanding "critical infrastructure" protections
- Permit Requirements: Obstructive red tape for legal demonstrations
- Anti-trans & Anti-migrant Statutes: Disqualify large portions of the population from protection
- **Terrorism Redefinition:** Redesignating activists and mutual aid workers as domestic extremists
- Custody/Guardianship Laws: Used against parents of queer/trans youth

Purpose: Criminalize dissent without visible violence. Shift from open repression to legal suffocation.

2. POLICING & SURVEILLANCE EXPANSION

- Fusion Centers: Shared data across ICE, police, DHS, FBI
- Drones & Aerial Surveillance: Protest heat mapping, riot detection
- **Stingray Devices:** Phone signal interception
- Facial Recognition Systems: Pulled from DMV, school, or social media
- Unmarked Officers: Extraction squads without ID
- Military Equipment in Policing: MRAPs, tear gas, flashbangs in civilian zones

Purpose: Total visibility and tactical dominance. Dissuade presence through hyper-policing.

3. ECONOMIC WARFARE

- Bank Account Closures: Based on activist affiliations
- Employment Blacklisting: Through background checks or Al flagging
- Landlord Threats / Eviction Backdoors: Against organizers or tenants of interest
- Restricting Mutual Aid Funding: Targeting GoFundMe, Venmo, or PayPal under false
 pretexts
- Denial of Benefits: Cutting state aid to those marked as "threats"

Purpose: Isolate, impoverish, and make resistance materially unsustainable.

4. PSYCHOLOGICAL & CULTURAL CONTROL

- Fear Campaigns: Inflated penalties, media fear cycles, trauma loops
- Erasure Tactics: Banning books, silencing language, destroying archives
- **Co-optation:** Creating "respectable" versions of movements to redirect momentum
- **Public Shaming:** Framing rebels as criminals, perverts, or mentally unstable
- Forced Apoliticization: Targeting trans joy or art that's "too loud, too radical"

Purpose: Make people fear organizing, doubt themselves, and avoid visibility.

5. DIGITAL SUPPRESSION & ALGORITHMIC TARGETING

- Shadowbanning & Throttling: Limiting reach of activist accounts
- **Al-based Profiling:** Predictive policing of protest patterns
- **Platform Terms of Service:** Weaponized against whistleblowers
- Bot Flooding & Disinfo Spam: Making truth unreadable through volume
- Social Credit Proxies: Tied to online behavior (especially abroad)

Purpose: Silence digital organization and isolate cells. Cut off communication and virality.

6. NARRATIVE WARFARE & MEDIA CENSORSHIP

- Language Shifting: Calling resistance "riots," calling police "restorers of order"
- Selective Coverage: Erasing successful direct actions or mutual aid
- Controlled Experts: Only platforming regime-friendly academics or NGOs
- "Both Sides" Framing: Equating hate and liberation
- **Pre-emptive Discrediting:** Painting future events as criminal before they happen

Purpose: Confuse the public, delegitimize resistance, and manufacture consent.

7. DIVIDE & FRAGMENT TACTICS

- False Flag Infiltration: Agents provocateurs creating chaos to justify crackdown
- **Cultural Gatekeeping:** Pit "good" activists against "bad" ones (especially around violence or identity)
- Racialized Displacement: Dividing movements along class, race, or disability lines
- NGO Assimilation: Buying off leadership into policy circles that pacify demands
- **Narrative Rewriting:** Replacing origin stories with state-approved myths

Purpose: Prevent unity, seed mistrust, and destroy collective momentum.

CONCLUSION

Every regime wants to convince you that **resistance is unnatural**, that your refusal is a disruption, not a warning.

But we know better.
